**DANGER:**

**PREVENTION:**  
Keep away from heat, open flames, sparks. - No smoking. Avoid breathing mist/spray. Wash thoroughly after handling. Contaminated work clothing must not be allowed out of the workplace. Wear eye protection, protective clothing, protective gloves. In case of inadequate ventilation, wear respiratory protection.

**IF SWALLOWED:** Immediately call a doctor, a POISON CENTER. Do NOT induce vomiting.

**IF ON SKIN:** Wash with plenty of soap and water.  
**If skin irritation or rash occurs:** Get medical advice/attention. Take off contaminated clothing and wash it before reuse. Wash contaminated clothing before reuse.

**IF INHALED:** If breathing is difficult, remove person to fresh air and keep comfortable for breathing.

**If experiencing respiratory symptoms:** Call a doctor, a POISON CENTER.

**IF IN EYES:** Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

**If eye irritation persists:** Get medical advice/attention.

**In case of fire:** Use carbon dioxide (CO2), dry extinguishing powder, foam to extinguish.

Store in a well-ventilated place. Keep cool. Store locked up.

**DISPOSAL:**  
Dispose of contents/container to comply with local/national/international regulations.

A unique combination of essential oils and natural extracts give **SCENTILLA CHERRY ORCHARD** maximum strength odor suppression. **DIRECTIONS:**  
Spray into the center and corners of room. Avoid spraying directly onto plastic surfaces. For extended odor control, moisten granules in a scent cup with 6 to 12 pumps of a sprayer (or pour directly from container) and place in the room where air currents will carry scent.
