**SURFACTANT** is a specially formulated spreading and sticking aid developed to increase the effectiveness of water-based pesticide chemical sprays. **SURFACTANT** reduces the surface tension of fertilizer and pesticide solutions and allows them to penetrate soil quickly, for less run off and waste. The wetting and sticking action of **SURFACTANT** also assures even and thorough coverage of foliage and reduced wash-off of expensive chemicals. **SURFACTANT** is key to optimum performance and cost effectiveness of pesticide chemical application.

### DIRECTIONS:

The quantity of **SURFACTANT** to be used will depend on water hardness, type of foliage, spray material used, equipment used, and the degree of wetting or coverage desired. In areas of soft water, use as little as 1/2 pint per 100 gallons. In areas of hard water, use 1 pint of **SURFACTANT** per 100 gallons. For larger mixes of pesticide spray solutions, add 1 gallon of **SURFACTANT** per 1000 gallons of solution, or follow the recommendations on the pesticide manufacturer's label.
